- 2. The registration process opens on 12:00pm NZST on 4 March 2024 and closes at 12:00 NZST on 22 March 2024 ("**Registration Period**").
- 3. All Applicants that receive a formal invitation via email to their student email address ("**Email Invitation**") are eligible to register to attend the Event. MDS reserves the right to revoke any graduation invitations at their discretion.
- 4. To register, Applicants must during the Registration Period comply with the following (when applicable):
  - (a) Submit their Registration to confirm attendance online via the link supplied in their Email Invitation.;
  - (b) All Event registrations are deemed to be received at the time of receipt by MDS and not at the time of transmission by the Applicant;
  - (c) All Event registrations must be received with the Registration Period as confirmed in the Email Invitation. No late registrations will be accepted.
  - (d) MDS reserves the right to request the Applicant to provide proof of age and identity (when applicable).
  - (e) The event is free and requires no payment

## General

- 5. Any Applicant that does not formally RSVP to the Email Invitation will graduate in absentia and their testamur will be mailed to them. The Applicant must ensure they supply their correct postal address to the Student Administration team prior to the end of the Registration Period.
- 6. MDS reserves the right to refuse an Applicant entry to the Event. Any persons whose behaviour is carried out in a manner deemed inappropriate by MDS including but not limited to being noisy, drunk, threatening or unruly will be asked to leave the premises.
- 7. At the time of registration, MDS provided the most recent information available and the Applicant accepts that the content and/or the delivery of the Event can change beyond the control of MDS. MDS will not take any responsibility for any errors, omissions and changes to the program or content of the event. MDS

reserves the right to make changes as it deems necessary without penalty.

- 8. MDS reserves the right to update these Terms and Conditions without notice to the Applicant.
- 9. MDS cannot control all content published or disseminated at the Event. You may find other Applicants' or participants' communications, graphics, audio files or other information inappropriate, offensive, harmful or inaccurate, however you alone are solely responsible for your interaction with other Applicants and agree to act responsibly and exercise caution, common sense and safety while in attendance at the Event.

- 27. While under no obligation to do so, MDS will consider any reasonable request not to use or to stop using a particular Recording. Such requests should be made in writing to events@mediadesignschool.com

## Privacy

- 34. MDS, its directors, employees, servants, agents and affiliates shall not be liable for any Applicant's loss, damage, liabilities, claims or expenses whatsoever arising out of or referable to the Event.

license and restrictions that may arise to COVID-19), wars, insurrections and/or any other cause beyond the reasonable control of the party whose performance is affected.
